## SRNS Employees Present \$32K Donation to Children’s Place

AIKEN, S.C. (May 30, 2017) – Savannah River Nuclear Solutions (SRNS) recently presented Children’s Place Inc., with a \$32,794 donation, which was achieved by SRNS employees during the annual Celebrity Waiter event on May 15.
